TRAI Streamlines Billing Audits and Cracks Down on Overcharging

Telecom consumers in India can now breathe a sigh of relief, thanks to a new set of regulations released by the TRAI on September 11, 2023. These "Quality of Service (Code of Practice for Metering and Billing Accuracy) Regulations, 2023" (QoS Regulations) put consumer protection at the forefront by:

- Reducing unnecessary audits: Instead of four audits per year, telecom service providers (TSPs) will now be audited only once annually, reducing unnecessary burdens and streamlining the process.
- 2. Hitting overcharging where it hurts: To stop TSPs from overbilling, hefty upfront financial disincentives (FDs) will be imposed as a percentage of the overcharged amount. This puts the onus on TSPs to get it right the first time.
- 3.No more self-evaluations: The practice of TSPs self-evaluating before an audit is thrown out, ensuring fairer and more independent assessments.
- 4. Choice for TSPs: TSPs will now have more flexibility in choosing which areas are audited each quarter, allowing them to optimize their compliance efforts.
- 5. More time for data: Recognizing the complexity of call data analysis, the deadline for submitting raw data records to auditors has been extended from 15 to 30 days.
- 6. Proportionate penalties: Instead of a onesize-fits-all approach, graded FDs will be applied based on the extent of delays in submitting audit reports, ensuring penalties are fair and proportionate.
